

Knightbloom Metals Monthly Giveaway TERMS & CONDITIONS

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The Knightbloom Monthly Giveaway (the "Sweepstakes") is open only to legal residents of the United States, the District of Columbia, and Canada (excluding Quebec) who are at least the age of majority in their state or province at the time of entry and are members of the Twitch community, WolfAtYourGate's Discord, and in good standing and not currently banned in WolfAtYourGate's channel.

2. Entry Period: The Sweepstakes begins at 12:00 AM PT May 1st, 2026 and ends at 11:59 PM PT on May 31st, 2026 ("Entry Period"). Each month that Knightbloom Metals decides to host a monthly giveaway, the entry period will repeat at similar time on the first and last day of each month. Entries submitted before or after the Entry Period will not be eligible. Sponsor's computer is the official time-keeping device for the Sweepstakes.

3. How to Enter:

a) There are two (2) ways to enter: 1. Providing a \$5.00 USD Tip to WolfAtYourGate: To enter the Promotion, during the Entry Period, eligible entrant ("Entrant") must: (a) complete a \$5.00 USD tip to WolfAtYourGate or a \$5.00 USD entry fee to Knightbloom Metals. Eligible tips can be made online at <https://streamlabs.com/wolfatyourgate/tip> or entry fees may be provided at <https://knightbloometals.com/giveaway> and both must include the Entrant's email address. Entrant must provide shipping information to Sponsor within one week of Drawing.

2. By Mail: Neatly print your first and last name, mailing address, email address, and telephone number along with Knightbloom Metals Monthly Sweepstakes on a 3" X 5" postcard. Please mail to Bethany Caitlan Nicole, ATTN: SWEEPSTAKES, 4821 Lankershim Blvd F296, North Hollywood, CA 91601. Entries must include the month and year of the Sweepstakes being entered. Entries must be postmarked during the Entry Period and received before the drawing date. Entries received after the drawing date will not be acknowledged.

b) For all Entries: There is a limit of one (1) entry per person per day during the Entry Period. However, there may be multiple entries on any given day but not more than the total number of days in the entry period cumulatively. Any entries attempted through the use of agencies or robotic, repetitive, automatic, programmed, or similar methods will be void. Participation in the Promotion constitutes Entrant's full and unconditional agreement to these Official Rules and the decisions of the Sponsor, which are final and binding. 4. Drawing: On or around the 1st of the following month after the entry period, the Sponsor will randomly select one (1) potential winner ("Winner") in a random drawing of all entries received. The odds of being selected depend on the number of entries received. ENTRANT CONSENTS TO BEING CONTACTED IN THE EVENT OF BEING NAMED WINNER OF THE SWEEPSTAKES. Sponsor will attempt to notify the potential Winner following the conclusion of the sweepstakes. Sponsor will attempt to notify potential Winner twice via Discord message, Twitch whisper, or email within five (5) days of the drawing. If a potential Winner does not respond within three (3) days after Sponsor's notification, Sponsor may select an alternate potential winner replacement at random from all remaining entries received.

5. Potential Winner Requirements: Except where prohibited, a potential winner may be required to complete and return a declaration of eligibility and liability/publicity release. If a winner is a legal resident of Canada, he/she will also be required to answer a time-limited, mathematical skill-testing question. Failure to answer the question correctly within the time period specified, as determined by Sponsor in its sole discretion, will result in disqualification and, at Sponsor's sole discretion, the prize may be awarded to an alternate winner for the sweepstakes at issue.

You further agree that for any cause of action, in no event shall the Released Parties be liable for attorneys' fees or other legal costs. You waive the right to claim any damage whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

Disputes: You agree that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in California.
